The regional breakdown of federal R&D expenditure is based (in most cases) on the main locations of the R&D-performing institutions concerned. In the case of jointly funded research by the Federal Government and the Länder, and in compliance with their agreement on research funding, R&D expenditure has been broken down in accordance with the requirements of the funded institutions. R&D expenditure of the Federal institutions with research and development tasks has been broken down in accordance with the locations of the institutions' headquarters and main branch offices (i.e. offices that are virtually institutions in their own right). The regional breakdown does not reflect the regional impacts of sub-contracts in which funding has been transferred across Länder boundaries. Possible deviations from earlier publications due to subsequent changes in the allocation to R&D or subsequent changes in the allocation to the federal Länder are possible.
